<u>Answer 1</u>: The signed bid does become the contract; however, there may be an opportunity to negotiate certain terms of the agreement prior to final signature. If the potential vendor has exceptions, they should provide a written record of these exceptions as part of their bid response for further discussion.

**Question 2**: For your consideration, in order for us (and other bidders, I would assume) to put forward the most compelling bid possible, it would be helpful to have an extension in the RFP submission deadline. Is this something you would consider?

Answer 2: The bid due date will be changed to reflect the date and time of November 8, 2024, at 2:30pm EST.
